

THE OFFICIAL REGULATION OF CAMPAIGN “*Say no to waste!*”

SECTION 1. Campaign Organizer

Article no. 1.1. The organizer of the campaign for the collection of waste electrical and electronic equipment (WEEE) “*Say no to waste!*” is the **RESPO WEEE ASSOCIATION**, Romanian non-profit legal entity, established based on the Resolution No. 4944/23.04.2019 delivered by Buftea Court in the file no. 6190/94/2019, registered under the no. 54PJ/ 14.06.2019 with the Special Register of Associations and Foundations, holder of Operating License No. 09/02.08.2019 issued by the Ministry of Environment, having its registered office in Bucharest, 13 Radu Captariu Str., 2nd floor, District 2, Tax Registration Number (CIF) 41292468, and email address for correspondence purposes: office@respo.ro, Tel: 021.796.92.72, represented by Mr. Cristian Ioan Pocol - Chairman hereinafter referred to as the **Organizer**).

Article no. 1.2. The program will be carried out according to the provisions of this Regulation which is mandatory for all participants. The program aims to inform and raise public awareness on the importance of separate collection of waste electrical and electronic equipment and the recycling thereof.

Article no. 1.3. The Organizer reserves the right to unilaterally modify / supplement this Regulation, as well as the right to temporarily suspend or permanently terminate the Campaign, provided that the participants are notified in advance by publishing the changes / measures on the website www.respo.ro.

Article no. 1.4. The campaign may be interrupted in the event of force majeure, in a state of emergency, fortuitous event or by a decision of the Organizer, where it deems it necessary, but not before publishing such information on the campaign webpage or on the organizer's website.

Article no. 1.5. Participation in the Campaign implies full, express and unequivocal knowledge and acceptance by the participants of these Regulation.

SECTION 2. Definitions

Article no. 2.1. For the purposes of this Regulation, the terms and expressions below have the following meaning:

a) **WEEE - waste electrical or electronic equipment** that is / was dependent on an electric current or electromagnetic field to function properly independently. This means that the equipment has been supplied directly by the power supply or batteries and has been intended for independent operation, and not as accessory or peripheral equipment of other main equipment.

b) Class A WEEE - discarded waste electrical or electronic equipment that is complete, without having been dismantled or suffering mechanical shocks likely to significantly deform its structure and without having been contaminated with hazardous materials / substances that could likely to endanger the life or health of those who treat them or affecting the treatment process, meeting at least the following specific conditions:

1. The refrigeration equipment must contain: the entire refrigeration circuit (compressor, condenser, evaporator), all doors, power cord;
2. Large appliances must contain in particular, depending on their type, the following: electric motors, electric resistances, vats and drums, doors and metal housing, electronic plates, power cord.

SECTION 3. Purpose and objectives of the campaign

Article no. 3.1. The program ***“Say no to waste!”*** aims to increase the level of information and awareness of the population on the importance of selective collection of waste electrical and electronic equipment (WEEE), in order to recycle them, and to increase the amounts of WEEE waste collected from the population in order to meet the objectives set by GEO No. 5/2015.

SECTION 4. Period and scope

Article no. 4.1. The information, public awareness and WEEE waste collection campaign is organized and takes place in the Romanian localities, registered and selected in the campaign, in accordance with the provisions of this Regulation. The regulation is drawn up and will be made public as per the legislation enforceable in Romania.

Article no. 4.2. The program will be carried out during, and the localities, the calendar and the time interval will be communicated through the promotion means of the campaign (posters, flyers).

Article no. 4.3. An information program and a calendar for collection are to be established for each participating locality.

Article no. 4.4. The collection from home is carried out following a request sent by phone call to **0800.800.219** or by email at **logistica@respo.ro**

SECTION 5. Participants and the right to participate

Article no. 5.1. The campaign can be attended by individuals residing in Romania, at least 18 years old upon the date of registration in the Campaign and who are domiciled within the localities participating in the Campaign.

Article no. 5.2. In order to enrol in the Campaign, the participants must hand in one or more used / old or defective appliances, electrical or electronic equipment, whole (not dismantled) at the fixed collection point located in the locality and communicated through information materials, during the campaign, as well as, as the case may be, at one of the mobile crews of the collection operators that will circulate in the locality, by prior appointment at **0800.800.219** or at the email address ***logistica@respo.ro***.

Article no. 5.3. The delivery of WEEE waste within the Campaign is carried out at the fixed collection point organized with the support of the mayor's office / LAU (Local Administrative Unite) or of the Organizer's partners, and for bulky equipment by lifting from home.

Article no. 5.4. As WEEE holders who may contain confidential information, trade secrets or personal data, the participants are required to make sure before handing over the waste that it has been formatted and does not contain stored information.

Article no. 5.5. The organizer is not responsible for the information stored on this equipment or for the way in which the subcontractors (collectors, transporters, capitalists or recyclers) manage them.

Article no. 5.6. By attending the campaign, the participants express their agreement in respect of the official Regulation of the campaign and are required to comply with the terms and conditions of this Official Regulation.

SECTION 6. Performance mechanism

Article no. 6.1. Any person owing and desiring to hand over one or more whole old (undamaged) appliances can register in the campaign at the collection point in their locality or at the collection operator designated throughout the Campaign.

Article no. 6.2. For large WEEE, participants can request their takeover from home by sending the request to the telephone number **0800.800.219** or to the email address ***logistica@respo.ro***.

Article no. 6.3. Upon handing over the household appliances and receiving the vouchers, the participants will sign a delivery note according to Annex 2 to the Regulations.

Article no. 6.4. Citizens will be informed through the organizers' own means, as well as through the representatives of local public authorities, in respect of the campaign that will take place on the date communicated on flyers and posters or through the mechanisms established by the Organizer (megaphone, local television, newspapers, Internet etc.).

SECTION 7. Personal data protection

Article no. 7.1. We want to assure you that the Organizer strictly complies with the General Data Protection Regulation no. 679/2016 and any other regulatory documents that regulate the protection of individuals with regard to the processing of personal data, and that we take all necessary legal measures for the practical implementation of the principles of legality, transparency, minimization and security of the processing of your personal data.

Article no. 7.2. The personal data of individuals that will be processed within the Campaign are as follows: name, surname, signature, telephone number and photos for the purpose of preparing the WEEE collection note (on paper and in electronic form), for registration, centralization and management of WEEE, in compliance with the legal rules and the traceability of the quantities of WEEE collected within this campaign, as well as for the purpose stated in Art.7.3. The data will be processed only based on your express consent.

Article no. 7.3. The RESPO WEEE Association will use the photos in which the participants appear - individuals who hand over WEEE - for the following purposes: to promote the results of the Campaign on RESPO WEEE website (*www.respo.ro*) or RESPO WEEE Facebook page, to be included in presentation materials in respect of RESPO WEEE's activity (looks back, newsletter etc.). The photos will be used for these purposes for a maximum period of 2 years.

SECTION 8. Force majeure and fortuitous event

Article no. 8.1 Force majeure is any external, unpredictable, absolutely invincible and unavoidable event which cannot be controlled, remedied, foreseen or prevented by the Organizer, including the impossibility of the Organizer, for reasons beyond its control, and of which occurrence makes impossible the fulfilment by the Organized of its obligations undertook under the Regulation.

Article no. 8.2. A fortuitous event is an event that cannot be foreseen or prevented by the person who would have been called to answer had the event not occurred.

Article no. 8.3. If a force majeure or fortuitous event prevents or delays, in whole or in part, the performance of the Regulation and the continuation of the WEEE collection campaign, the Organizer shall be relieved of the liability to fulfil its obligations for the period in which such fulfilment will be prevented or delayed, as per Art.1351 *et seq.* of the Civil Code. If the Organizer invokes the force majeure or the fortuitous event, it is required to communicate to the Participants to the WEEE collection campaign about the existence thereof within 20 business days as of the occurrence of the force majeure event.

SECTION 9. Litigation

Article no. 9.1. Any disputes between the Organizer and the participants in this WEEE collection campaign will be settled amicably or, if this is not possible, the disputes will be resolved by the competent Romanian courts at the Organizer's headquarters.

SECTION 10. Official Regulation of the WEEE collection campaign “*Say no to waste*”

Article no. 10.1. The Regulation of the ***Say no to waste*** campaign will be published on the website www.respo.ro and made available, free of charge, to any participant, throughout the performance of the Campaign, at the collection points.

Article no. 10.2. The Regulation is prepared and made available to those interested, free of charge, by the Organizer for each person who wishes to participate.

Article no. 10.3. By attending this Campaign, the participants agree to unconditionally comply with and observe the provisions of this Regulation and any subsequent amendments / supplementations.

SECTION 11. Termination of the Campaign

Article no. 11.1. The Organizer may decide to terminate this Campaign prior to the expiration date of the initially established duration, for reasons beyond its control, such as, but not limited to, the occurrence of an event constituting force majeure / fortuitous event, as per the laws in force, under the conditions expressly provided in the Regulation, as well as for the impossibility to continue this Campaign for objective reasons. This will be communicated on the website www.respo.ro.

ANEXA 1 – LIST OF WEEE CATEGORIES (AS PER ANNEX 4 OF GEO. NO. 5/2015)

1. Heat transfer equipment:

- refrigerators, freezers, vending machines for cold products, air conditioning equipment, dehumidification equipment, heat pumps, oil radiators and other heat transfer equipment using fluids other than water for heat transfer.

2. Monitor screens and equipment containing screens larger than 100 cm²:

- screens, TVs, LCD cameras, monitors, laptops, small laptops.

4. Large equipment:

- washing machines, tumble driers, dishwashers, cooking machines, electric stoves, electric hobs, lighting apparatus, sound or image reproducing equipment, musical equipment except pipe organs installed in places of worship, knitting and weaving appliances, large computer units, large printers, photocopiers, large coin machines, large medical devices, large surveillance and control instruments, large vending machines for products and banknotes, photovoltaic panels.

5. Small equipment:

- vacuum cleaners, carpet sweepers, appliances for sewing, luminaries, microwaves, ventilation equipment, flat irons, toasters, electric knives, electric kettles, alarm clocks and watches, electric shavers, scales, appliances for hair and body care, pocket computers, radio sets, video cameras, video recorders, hi-fi equipment, musical instruments, equipment reproducing sound or picture, electrical and electronic toys, sports equipment, computers for biking, diving, running, rowing, etc., smoke detectors, heating regulators, thermostats, small electrical and electronic tools, small medical devices, small monitoring and control instruments, small vending machines, small equipment with integrated photovoltaic panels.

6. Small computer equipment and electronic communications equipment, no external size greater than 50 cm:

- mobile phones, GPS, pocket computers, routers, personal computers, printers, telephones.
